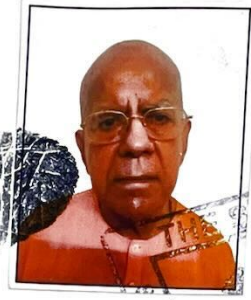

I am a Sannyasi and have no dependents.

I declare that I am in good health and possess a sound mind. This Will is made by me without any persuasion or coercion and out of my own independent decision alone.

I am a trustee of ISKCON India and BBT and a Governing Body Commissioner. I am not a trustee of any other trust except ISKCON Seva Trust (a Bureau Controlled Trust) an inactive Trust based in Delhi set up by the ISKCON Bureau.

I have always been loyal to the Governing Body Commission of ISKCON and the teachings of Srila Prabhupada, the Founder Acharya of the International Society for Krishna Consciousness, as reflected in his books. I would like all my disciples to follow the GBC body. I have never taken one step out of ISKCON and I desire that they render their services in ISKCON and not run here and there looking for some easy way out.

The Guru manifests himself in two ways- through Vapu and through Vani. Vapu, you may have heard many times- is temporary. Vani is permanent. So all my instructions are drawn and therefore reflected from Srila Prabhupada's books. Srila Prabhupada had said, "your love for me will be shown by how much you cooperate among yourselves" and my desire from all my disciples is the same- to cooperate among themselves and with ISKCON authority forever.

If I were to pass away outside India, I will be grateful if my body could be brought to Vrindavan or Mayapur and kept in Samadhi there. If I were to pass away in North India, I would like my Samadhi to be in Vrindavan. If I were to pass away nearer to Mayapur, I would like my Samadhi to be in Mayapur. There is a plot of land in Vrindavan where my disciples wanted to construct a house for me. I did not encourage that. It's my desire that, this particular land should be donated to ISKCON Vrindavan for any purpose they may deem fit. I see a different picture of mine in almost every temple where my disciples serve. They can choose any picture they like. This practice can go on after my departure also.

I don't really have any assets, cash, bank deposit lock box, vehicles, stocks or any property in my name. All the properties in the zones managed by me in ISKCON, are registered legally in ISKCON's name and there's nothing in my name except a Rolex Watch gifted by Srila Prabhupada in 1977, my laptop and two mobiles. I desire that this watch be handed over to one of my disciples who helped me serving Srila Prabhupada. The laptop and mobiles with all the logins and passwords will be in the custody of whoever will be my Secretary at the time of my leaving my body. My clothes and Sweaters can be distributed to disciples and other devotees by the team of my assistants. I have not authored any books except some lecture Transcripts brought out by different disciples at different places. There is no copyright owned by me on this.

My only True assets are my personal deities and I do not want these to be worshipped by any one individual. I therefore desire that my Saligram silas and the deities be kept in the altar and worshipped at Sri Sri Radha Parthasarathi Temple, ISKCON Delhi, Sri Sri Radha Radhika Raman Temple, ISKCON Punjabi Bagh and could be divided among other temples in my Zones. I desire so as, if the deities are part of the Temple altar, then They will be safe and in case they are worshipped by individuals, they could be abandoned. I do keep some little Lakshmi -as we describe money- to be used in Krishna's service for various projects and this could be divided among the different projects which will be ongoing at the time of my passing away. I have one joint bank account along with my disciple Jagannatha Priya Das in US and this has a balance of \$3000 for the past 4 years merely to ensure that I have transactions in an American account, to secure my green card. I have No personal loans nor do I owe any debts to anyone.

I hereby appoint 5 Doctor disciples who are personally serving me now as Attorneys to determine concurrently, my medical treatment and personal care in case of my not being in a position to decide.

If I were to pass away, I will be really pleased and grateful if all the disciples take shelter of one of the senior devotees in this movement, without being independent and follow the management system set up and provided by Srila Prabhupada.

Thank you for your service and love for Srila Prabhupada. Serving you has been my privilege."


